

## RITUAL ABUSE-TORTURE AND ACTS OF KILLING

Ritual abuse-torture (RAT) families and like-minded groups intentionally practice organized acts of:

1. **Child abuse**
2. **Terrorization** to silence victims
3. **Human-animal cruelty** i.e., the torture-killing of animals and bestiality
4. **Torture**--physical, sexualized, and mind-spirit
5. **Pedophilia**
6. **Necrophilism** i.e., pedophilic necrophilic acts include inducing "death-like" immobility by over-drugging or suffocating victims into unconsciousness then raping them
7. **Enforcing Self-harming/suicidal practices** among child/adult victims
8. **Human trafficking/enslavement** of victims in the off-street and on-street pedophilic/adult pornographic and 'sex' trade, regionally, nationally, or transnationally and forced involvement in criminal acts, i.e., drug trafficking
9. **Violent family/group gatherings** coded as 'rituals and ceremonies' that function as group bonding, groupthink, and group cohesive mechanisms, i.e., normalizing group raping of a toddler
10. **Horrification** i.e., child/adult victims report their forced involvement in sham or real killings.

RITUAL ABUSE-TORTURE is an emerging human rights violation and a newly acknowledged form of torture that is inflicted by non-state actors onto the girl and boy infant, toddler, child, youth, and captive enslaved woman.<sup>3</sup>

PREVALENCE Reported to occur in every region of Canada,<sup>4</sup> we have received reports from persons in Canada, Australia, England, Germany, Holland, Israel, New Zealand, Scotland, and the United States.

OVERCOMING OPPRESSION means

1. Society needs to acknowledge the human rights violations and suffering of persons who have survived RAT
2. Effective carers need to:
  - (a) respectfully hear, believe, and understand RAT violations
  - (b) stay present and ask questions as persons talk, write, draw, journal, or use other creative media to process RAT killing horrification ordeals
  - (c) assist with reality checks to help undue on-going enslaving distortions
  - (d) allot time for a victimized person to regain their equilibrium after telling
  - (e) encourage a victimized person to write their story or have help to write it; see examples on our website
3. Society—bystander, carer, and victim—needs to engage in activism.

## KILLOLOGY

Killology refers to the study of key processes involved in the human act of killing other humans.<sup>1</sup> Based on reports given to us from persons who have survived RAT, adult perpetrators, singularly or as a family/group, have killed in the following circumstances:

- 1. CHILD HOMICIDES** i.e., described to authorities as ‘accidents’ involving ‘falls’ from high places or down a flight of stairs, or as drowning or burnings.
- 2. ‘SNUFF’ KILLINGS** committed during the production of pedophilic or adult pornography.
- 3. RACIALLY-BASED KILLING** i.e., ethnic torture-killing of child/adult.
- 4. STRANGER KILLING** i.e., of runaways, the homeless, or obtaining a trafficked child for torture-killing.
- 5. TRAITOR, INTIMIDATION, or OTHER KILLING** i.e., mafia-type killing of a person deemed a risk to the RAT family/group; killing to show power and threaten other groups, or planned programmed ‘hit’ killings.
- 6. HUMAN EXPERIMENTATION KILLING** i.e., RAT families/groups ‘supply’ their victimized and traumatized children to evil-based ‘scientific researchers’/pedophiles who conduct inhumane torturous experiments—some children are killed.
- 7. PREPARATORY SUICIDE-KILLING** i.e., captive enslaved children of ‘the family’ are prepared—conditioned/programmed—trained or schooled—to commit suicide should they try to exit; adult survivors report conditioned/programmed urges to drive into an embankment or through a

red light if they tell or think of telling.

**8. ‘PROFESSIONAL COUNSELING’ SUICIDE-KILLING** i.e., exiting persons tell of therapists, connected to RAT families/groups, who attempted to silence them by abusing professional power and skill using post-hypnotic suggestion to reinforce childhood suicidal programming or activate a call-back/suicide program by mailing a triggering drawing to them.

**9. INFANTICIDE** i.e., (a) with twins one twin is killed, (b) an infant is kept alive for infant pornography then killed, (c) an infant or toddler is used as a ‘tool’ to inflict mind-spirit torture onto the infant’s captive enslaved teenage mother, forcing her to witness and comply with the RATers demands to prevent (unsuccessfully) the killing of her infant, and (d) during violent organized family/group gatherings an infant or toddler is ‘sacrificed’—an euphemism for killed.

**10. REPRODUCTIVE VIOLENCE** i.e., family/group raping and impregnation of captive enslaved girls and women and forced abortions including reports of the cannibalization of fetal tissue.

## SURVIVING

Victimized persons suffer horrification responses as they struggle to survive. Horrification memories re-produce many of these responses, such as:

1. Intense repugnancy, shame, nausea, vomiting, and gagging cough
2. Helplessness, survivor guilt/suicidal
3. Hypersensitivity to sound, insomnia, nightmares, irritability, nervousness, jumpiness, mood swings of elation and

depressiveness, and crying episodes

4. Voicelessness, stuttering, temporary loss of vocabulary and inability to express one’s Self cognitively
5. Palpations, tremors, convulsive attacks, and violent body shakes
6. Curling up into a fetal position and peeing or pooping incontinently
7. Extreme fatigue, vulnerable for total physical, mental, and emotional burn out and collapse, concentrating and problem-solving difficulties, confusion —‘brain fog’, forgetfulness, body memories, flashbacks, or Self-harming
8. Avoidance of social connections, isolation, and loss of interest in life
9. Panic, fear, terror, and horror attacks and deep inner coldness
10. Overwhelming emotions, including anger, expressed by walking in circles or spinning around with arms flailing
11. Temporary partial or total body paralysis, objectification and depersonalization of one’s body
12. Disorientation, not aware of where one is, aimless wandering and driving, and ignoring evident social dangers
13. Forgetting/blacking out episodes, out-of-body experiences, dissociation from reality, altered states, and fragmentation of one’s Self.

## WHO ARE THE PERPETRATORS OF ACTS OF KILLING?

They are every adult involved in RAT families/groups who force a captive enslaved child or adult victim to witness or be involved in acts of RAT killings—be they mother or father, other like-minded family members, friends, or neighbors, professionals, clergy, or layperson.
